The attention of all the District Educational Officers & Ex-Officio, District Project Officers, Samagra Shiksha in the State is invited to the references 1st to 3rd read above.

They are aware that the General Merit List for all categories of posts received from TS Online for the online tests held on 23.12.2019 & 24.12.2019 for filling up of vacancies of Data Entry Operators, Inclusive Education Resource Persons, MIS Co-ordinators, System Analysts and Assistant Programmers in District Project Offices and Mandal Resource Centers as per this office notification in the reference 1st read above and its amendments in the reference 2nd read above was mailed to them vide reference 3rd read above. But, the process of selection was withheld at that time.

In this context, in view of permission accorded vide references 4th & 5th read above, the process of positioning the services of personnel in the vacant posts purely on contract basis as notified vide reference 1st read above and its amendments in the reference 2nd read above has to be taken up now. With regard to sub clause b & c of Clause 13 of Notification, the following revised criteria is applicable.

The relevant certificates may be got ready with authorized signature and kept with the candidates to produce as and when required.	c. Reservation to the Local candidates will be applicable. The candidates claiming reservation as Local candidates shall obtain the required Study Certificates (from Class I to Class VII) (OR) Residence Certificate in the Proforma only for those candidates who have not studied in any Educational Institutions as the case may be. The relevant certificates may be got ready with authorized signature and kept with the candidates to produce as and when required (as per amendment dated 18.11.2019 to the Notification dated 06.11.2019)

Therefore, all the DEOs & EO-DPOs, SS in the State are requested to take up process of positioning the services of personnel in the vacant posts purely on contract basis as notified vide reference 1st read above, its amendments in the reference 2nd read above and modified sub clause (b) & (c) of Clause 13 of Notification duly following the under mentioned schedule.


1. To follow the guidelines issued in the Notification dated 06.11.2019 and its amendments & modification to engage the personnel purely on contract basis strictly.
2. To follow the Schedule for selection process strictly.
3. As per Clause (6) of Notification, selection of candidates will be based on merit and rule of reservation. Further as per Clause (11) (i) of Notification, unit of recruitment is New District. Therefore, fresh roaster (starting from cycle 1) has to be drawn for each category of post new District wise.



1. Applications are invited through Online from qualified candidates for filling up vacancies of MIS-Coordinators in Mandal Resource Centers/Data Entry Operators in District Project Office and Mandal Resource Centers / System analyst at District Project Office /Assistant Programmer/Inclusive Education Resource Persons at Mandal Level purely temporarily on contract/outsourcing basis. 2. The **State Project Director** reserves the right to conduct the Examination either **COMPUTER BASED RECRUITMENT TEST (CBRT)** based Examination in objective type for filling up of vacancies of following category of the Posts
 - a. MIS-Coordinators
 - b. Data Entry Operators
 - c. System analyst
 - d. Assistant Programmer
 - e. Inclusive Education Resource Persons.
3. The candidates must read instructions thoroughly before filling Online applications.
4. The candidates who possess requisite qualification may apply online by satisfying themselves about the terms and conditions of the Test. The number of vacancies are subject to variation on intimation being received from the District Educational Officers concerned i.e., competent authority.
5. Educational Qualifications: Applicants must possess the qualifications as prescribed for the post from a recognized University/Institution as specified at item (16) Qualifications.
6. Selection of candidates shall be on the basis of marks secured in the Written Examination by following rule of reservation.
7. The Candidates who have obtained Degrees through Open Universities / Distance Education mode are required to have recognition by the University Grants Commission / AICTE / Distance Education Council as the case may be. Unless such Degrees are recognized by the relevant Statutory Authority, they will not be accepted for purpose of Educational Qualification. The onus of Proof of

recognition by the relevant Statutory Authority that their Degrees / Universities have been recognized rests with the Candidate.

8. Age:

Age limit is below 34 Years as on 01.07.2019.(5) Years relaxation is given in case of SCs/STs/BCs and (10) years in case of Physically Challenged Persons(PH vacancies shall be converted to open).

9. Centres For The Online Examination:

- a. The Examination will be held at the Centres located at STATE Head Quarters (Hyderabad).
- b. The Commissioner School Education & Ex Officio State Project Director reserve the right to allot candidates to any Centre other than the Centre chosen by the applicant or to abolish / create a new Centre at District Headquarters for administrative reasons. Request for change of the Centre will not be entertained.

10. How To Apply:

- a. The Candidate has to visit the Samagra Shiksha Website www.samagrashiksha.telangana.gov.in and fill the application duly following the guidelines at the time of registration. While filling the application form, the candidates have to ensure that there are no mistakes in it.
- b. Applicants are solely responsible, for any discrepancy in Bio-data particulars while submitting the application form through Online. The applicants are therefore advised to strictly follow the instructions before submitting the application.
- c. The particulars furnished by the applicant in the Application Form shall be taken as final and the applications are processed, based on these particulars only. Candidates should, therefore, be very careful in Uploading / Submitting the Online Application Form.
- d. Applicants should be careful while uploading / submission of Application Form, duly satisfying their eligibility for the examination. Ensure that no relevant columns in the application should be left blank, if so their application form will not be accepted.

- b. The applications submitted through online in the prescribed proforma available in the website within the stipulated time will only be considered.
- c. Applicants must upload his/her scanned photograph (Passport Size) and signature through J.P.G format. (3.5x4.5 mb).
- d. The applicants should not furnish any particulars that are false, tampered, fabricated or suppress any material information while making an application through website.
- e. All the essential certificates issued by the competent authority of Telangana State shall compulsorily be kept with the applicants to produce as and when required to do so. Failure to produce the required certificates on the day of verification will lead to disqualification.
- f. Mere submission of application or appearing for the exam do not confer any right to the candidate for considering his/her engage in to the Project. The candidature is therefore, provisional at all stages and Commissioner, School Education & EO-State Project Director, Samagra Shiksha, Telangana, Hyderabad reserves the right to reject the candidature at any stage of the process.
- g. The claim of the candidates with regard to the date of birth, educational / technical qualifications, experience and community are accepted only provisionally on the information furnished by them in their application form and is subject to verification and satisfaction of the Competent Authority. Mere admission to any test or inclusion of the name of a candidate in a Merit List will not confer on the candidate any right to engage on contract basis. 12. Important Legal Provisions Governing The Test Process:

a. Vacancies: The test process is not made on the vacancies available but the services of the candidates would be drawn from merit list as per the need/requirement in the concerned district to engage them on contract basis duly following rule of reservation.

b. The District Educational Officers are also empowered to invoke the penal provisions in force.

c. Caste & Community: Community Certificate issued by the competent authority (obtained from Government of Telangana State) in terms of G.O.Ms No. 58, SW (J) Dept., dt: 12/5/97 read with G.O. Ms. No. 5 Scheduled Castes Development (POA.A2) Dept., Dt. 08/08/2014, G.O. Ms. No. 11 Scheduled Castes Development (POA.A2) Dept., Dt. 17/09/2014 and G.O. Ms. No. 2 Scheduled Castes Development (POA.A2) Dept., Dt. 22/01/2015 should be submitted at appropriate time in respect of SC & ST Candidates. In respect of candidates belonging to Backward Classes are required to produce Community Certificate (BC-A, BC-B, BC-C, BC-D& BC-E) from Competent Authority i.e., from

Tahsildars in the State of Telangana not below the rank of Deputy Tahsildar through E-seva/ Mee-seva (G.O. Ms. No. 16 BCW(OP) Dept., Dt. 11/03/2015) and orders and instructions issued by the Government from time to time. No person who professes a religion different from Hinduism shall be deemed a member of Schedule Caste. BC's, SC's and ST's belonging to other states are not entitled for any kind of reservation.

13. Reservation:

- a. Rule of Reservation will be applicable.
- b. Only local tribes are eligible for the posts in the agency area.
- c. Reservation to the Local candidates will be applicable. The candidates claiming reservation as Local candidates shall obtain the required Study Certificates (from Class IV to Class X or SSC) (OR) Residence Certificate in the Proforma only for those candidates who have not studied in any Educational Institutions as the case may be. The relevant certificates may be got ready with authorized signature and kept with the candidates to produce as and when required.
- d. The Local Candidature will be based on new districts only.

14. Criteria for consideration: The consideration for engaging the services will be based on the marks and merit in the Exam. Those candidates who qualify as per minimum qualifying marks and order of merit for consideration will be called for verification of Certificates, Community and Category wise as per the need/requirement.

15. The minimum qualifying marks for consideration are OCs 40%, BCs 35% SCs, STs and PHCs.
